**Scope and Content** (written by Corinne Florin for the earlier edition of this finding aid) The Minnesota State Board of Medical Examiners alleged that Dr. Richard E. Olsen, D.C., of Paynesville, Minnesota, was unlawfully using four machines in his chiropractic practice that they considered were for medical use only. Because of these allegations, a lawsuit was filed and trial was held on January 21, 1970, in Supreme Court of the State of Minnesota before the Honorable Paul Hoffman.

The Board sought to enjoin Dr. Olsen from using the machines identified as:

- the Aloesine X-ray and physical therapy device
- the Megason VI Model 105-6 ultra-sound device
- the Dallans Mediline Model 1400 MSR muscle stimulator
- the Liebel-Flarsheim Model SW-660 diathermy device

The machines in question were ultra-sound, heat-producing devices and used primarily by Dr. Olsen as muscle relaxants to prepare his patients for chiropractic adjustments. The testimony from the medical experts countered that these devices were used in hospitals, medical clinics, and physical therapy offices throughout Minnesota, but always under specially trained *medical* personnel. Dr. Olsen's depositions stated that he received extensive instruction in the nature and application of these and other physical therapy devices while at Northwestern College of Chiropractic.

The Board of Medical Examiners maintained that because the use of these devices was outside the scope of chiropractic and since these devices can cause serious injury when not under the supervision of a duly licensed physician, Dr. Olsen was unlawfully practicing medicine. Specifically, it stated that the practices of Dr. Olsen "will result in great and irreparable harm to the safety and health of the public for whose benefit this action is brought."

Dr. Olsen acknowledged that he used the devices in his practice of chiropractic medicine, but there was no testimony presented that any harm or injury ever occurred during Dr. Olsen's treatments with these

machines, nor were any records of complaints by any patient of Dr. Olsen's regarding the use of these devices brought in as evidence against Dr. Olsen.

Attorneys for the Minnesota State Board of Chiropractic Examiners showed that as early as 1927 the Attorney General recognized their right to use "electro-therapy" in connection with chiropractic treatment. He advised, "If the use of electro-therapy and other drugless methods is confined to the practice of chiropractic as defined by the statute, I am of the opinion that such use by licensed chiropractors is permissible."

The Minnesota Supreme Court upheld this opinion, and agreed with a 1969 opinion from the Attorney General reinforcing the earlier opinion. The later statement reads, "We have concluded...that the practice of chiropractic encompasses any diagnostic or therapeutic technique reasonably appropriate to the adjustment of abnormal articulations for the purpose of giving freedom of action to impinged nerves."
