Mark E. Brewer, D.C., practiced chiropractic at 3800 Shoreline Drive, Wayzata, MN. He retired in 2018. Brewer graduated from Logan College of Chiropractic in 1983. He appears on *Minnesota Monthly's* Best Chiropractors list for 2017.

The materials in this collection were gathered by Mark E. Brewer in the course of his chiropractic practice. Materials include notes and publications on chiropractic theory and practice, including continuing education materials, patient education publications, non-chiropractic manual therapy publications, and realia. Material publication/creation dates are 1910-1984. Most materials are original copies of grey literature or ephemera. One item is an ultrasound machine, a Medco-sonlator Twin.
