NCMIC, in conjunction with the National Board of Chiropractic Examiners, launched the Bucks for Boards program in 2020. A total of 200 scholarships totaling \$100,000 each in the amount of \$500 each, will be given by NCMIC in 2021.

Four times during the year, 50 students will be awarded Bucks for Boards scholarships. The names of the winners will be randomly drawn from those who enter each entry period. Students may sign up once per entry period and are eligible to win one NCMIC Bucks for Boards scholarship in annually. Winners will be notified by email and/or phone.
